#### DECLARATION OF RESTRICTIONS

KNOW ALL MEN BY THUSE PRESENTS:

That LANE TITLE & TRUST COMPANY, an Arizona corporation, as Trustee, being the owner of all of the following described premises, situate within the County of Gils, State of Arizona, to-wit;

Lots Sixty-two (62) to One Hundred Eleven (111), inclusive, COLCORD MOUNTAIN HOMESITAS, according to the plat of recording the office of the County Recorder of Gila County, Arizons, in Map file No. 239 , EXCEPTING Lot Ninety-four (94):

and desiring to establish the nature of the use end enjoyment thereof, does hereby declars said premises subject to the following express covenants, stipulations, and restrictions as to the use and enjoyment thereof, all of which are to be construed as restrictive covenants running with the title to said premises and with each and every part and percel thereof, to-wit:

- 1. All of said lots in COLCORD MOUNTAIN HOMESITAS shall be known and described as residential lots.
- 2. No structure whatever, other than one private, single-family dwelling together with a private garage, a must house, and servant quarters, shall be erected, placed or permitted to rumain on any of the lots; provided, however, that no facilities for the propretion of food shall be provided or permitted in any guest house or servants' quarters to be erected on said premises. The main dwelling to contain not less than 500 square feut of ground floor living area.
- 3. No store, office or other place of business of any kind, and no hospital, sanstorium, or other place for the care or trantment of the sick or disabled, physically or mentally, nor any theater, saloon or other place of entertainment, or any oburch, shall ever be created or cermitted upon any of the lots, or any part thereof, and no business of any kind or character whatever shall be conducted in or from any residence on the lots.
- 4. No lot shall be resubdivided into smaller lots nor conveyed or encumbered in less than the full orizinal dimension of the lct, as shown by the plat of CCLCORD WOUNTAIN HOMESITES, except for rubbic utilities.
- 5. No buildings shall be erected or maintained, except those which harmonize in design, building materials, and outside color with the natural forest setting.
- 6. No building, fence, well or other structure shall be commenced, erected or maintained, until the plans and specifications and nlot olan, showing the masure, kind, shape, height, matorials, floor plans, exterior color scheme, location and approximate cost of such structure and the grading of the lot to be built upon, including location, size and design of seware disposal unit, shall have been submitted to and approved by the Architectural Control Committee, hereinafter described, and a copy thereof, as finally approved, lodged permanently with said Committee. The Conmittee shall have the right are not suitable or desirable, in its opinion, for seathetic or other reasons, and in so passing upon such plans, specifications or grading plans, it shall have the right to take into consideration the suitability of the proposed building or other structure, and of the materials of which it is to be built, to the site upon which it is proposed to erect the same, the harmony thereof with the surroundings and the effect of the building or other structure as planned, on the outlook from the adjacent or neighboring property. All subsequent additions to or changes or alterations in any building, fence, well or other structure, including exterior color scheme, shall be subject to the prior approval of the Architectural Control Committee. All decisions of the Committee shall be final, and no lot owner or other parties shall have recourse against the Committee for

The Architectural Control Committee shall be composed originally of three members selected by the Board of Directors of Coloord Mountain Homesites. Any one member of this committee is empowered to approve or reject building plans and or specifications. The members of the Committee shall not be entitled to any compensation for services performed under this covenant. When fifty—one percent (51%) of the lots have been sold, the then record owners of a majority of the lots shall have the power, through a duly recorded instrument, to change the membership of the Committee.

- 6. No poultry, livestock, or other animals, other than saddle horses and the usual household pets, shall be permitted on any lot.
- 9. All dwellings upon which construction has started shall be completed promptly.
- 10. With the exception of one "For Rent" or "For Sale" sign (which shall not exceed 18 x 24 inches in size), no advertising signs, billboards, unsightly objects or nuisences shall be erected, placed or permitted to remain on any lot; nor shall the lots be used in any way or for the any purpose which may endanger the health or unreasonably disturb the holder of any other lot.
- 11. No elevated tanks of any kind shall be erected, placed or pormitted upon any lot. Any tanks for use in connection with any residence on the lots, including tanks for storage of gas, fuel, oil, gasoline or oil, must be buried or kept screened by adequate planting or fence work, which planting or fence work first be approved by the Committee, to conceal them from neighboring lots and streets.
- 12. All rubbish, trash or garbage shall be removed from the lots and shall not be allowed to accumulate thereon.
- 13. No outside toilets or open plumbing shall be permitted or swintained on any of the luts. All plumbing shall be connected to a certic tank or other system which complies with the health laws of the State of Arizons.
- 14. The aforesaid provisions, restrictions and comments, and each and all thereof, shall run with the land and every part thereof, and shall be binding on all the parties and all persons claiming under then until January 1, 1971, after which time they shall be automatically extended for a period of ten years, unless an instrument of each by a rejority of the then owners of the lots has been recorded, agreeing to change the same in whole or in part.

Failure to enforce any of these restrictions, rights, reservations, limitations, covenants ent conditions contained herein shall not, in any event be construed or held to be a waiver thereof or consent to any further or succeeding breach or violation. Invalidation of any one of these restrictions by judgment or court order shall in no wise affect any of the other provisions which shall ramain in full force and effect.

## PUBLIC ROAD EASEMENT

THIS EASEMENT, dated this 2nd day of October . 1987, from the UNITED STATES OF AMERICA, acting by and through the Forest Service, Department of Agriculture, hereinafter called Grantor, to the Gila County Board of Supervisors, hereinafter called Grantee.

### WITNESSETH:

WHEREAS, the Grantee has applied for a grant of an easement under the Act of October 13, 1964 (78 Stat.) 1089, 16 U.S.C. 532-538), for a road over certain lands or assignable easements owned by the United States in the County of Gila, State of Arizona, and administered by the Forest Service, Department of Agriculture.

NOW THEREFORE, Grantor does hereby grant to Grantee an easement for a public road and highway along and across a strip of land 50 feet on each side of the centerline hereinafter defined as the right-of-way over and across lands in the County of Gila, State of Arizona, as described in the plat entitled, "Plat of the Right of Way Survey Road No. 115A, Tonto National Forest, T. 10½ and 11 N., R. 13 and 14 E., Gila and Salt River Meridian, Gila County, Arizona," hereby made a part herebf. The plat has been recorded in the Gila County records found at "Road 115A, Record of Survey #242."

The word "right-of-way" when used herein means said strip of land whether or not there is an existing road or highway located thereon. Except where it is defined more specifically, the word "highway". shall mean roads or highways now existing or hereafter constructed on the right-of-way or any segment of such roads or highways.

This grant is made subject to the following terms, provisions, and conditions:

- 1. Outstanding valid clasms, if any, existing on the date of this grant.
- The easement herein granted is limited to use of the described right-of-way for the purpose of construction, operation, and maintenance of a highway and does not include the grant of any rights for nonhighway purposes or facilities; Provided, That the Forest Service shall not exercise its right to use or authorize the use of any portion of the right-of-way for nonhighway purposes when such use would interfere with the free flow of traffic or impair the full use and safety of the highway; and Provided further, That nothing herein shall preclude the Forest Service from locating National Forest and other Department of Agriculture information signs on the portions of the right-of-way outside of construction limits.

- 4. Consistent with highway safety standards, the Grantee shall:
  - (a) Protect and preserve soil and vegetative cover and scenic and esthetic values on the right-of-way outside of construction limits.
  - Provide for the prevention and control of soil erosion within the right-of-way and adjacent lands that might be affected by the construction, operation, or maintenance of the highway, and shall vegetate and keep vegetated with suitable species all earth cut or fill slopes feasible for revegetation or other areas on which ground cover is destroyed. The Grantee shall perform these activities where it is deemed necessary during a joint review between the authorized Forest Officer and Grantee prior to completion of the highway. Grantee also shall maintain all terracing. ars, leadoff ditches, or other preventive that; may be necessary to accomplish, bars. water this objective. This provision also shall apply to waste disposal areas and slopes that are reshaped during slides that occur following construction.

## 5. The Grantée shall:

Establish no borrow, sand, or gravel pits; stone quarry; permanent storage areas; sites for highway-operation and maintenance facilities; camps; supply depots; or disposal areas within the right-of-way, unless shown on approved construction plans, without first obtaining approval of the authorized Forest Officer.

6. The Grantee shall maintain the right-of-way clearing by means of chemicals only after the Forest Supervisor has given specific, written approval. Application for such approval must be in writing and must specify the time, method, chemicals, and the exact portion of the right-of-way to be chemically treated.

- The Grantee does by the acceptance of this document covenant and agree for itself, its assigns, and its successors in interest to the property here granted, or any part thereof, that the covenant set forth below shall attach to and run with the land:
  - (a) That the Grantee shall operate the described property and its appurtenant areas and its buildings and facilities whether or not on the land therein granted as a public road, in full compliance with Title VI of the Tivil Rights Act of 1964 and all requirements imposed by or pursuant to the regulations issued thereunder by the Department of Agriculture and in effect on the date of this document to the end that no person in the United States shall, on the grounds of race, sex, color, religion, or national origin, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any programs or activities provided thereon; and
  - (b) That the United States shall have the right to judicial enforcement of these coverants not only as to the Grantee, its successors and assigns, but also as to lessees and licensees doing business or extending services under contractual or other arrangements on the land therein conveyed.
  - The Regional Forester shall make determination as to the necessity for archeological and paleontological reconnaissance and salvage within the right-of-way, and such reconnaissance and salvage to the extent determined necessary because of maintenance of the highway facility is to be undertaken by the Grantee in compliance with the actentitled, "An Act for the Preservation of American Antiquities," approved June 8, 1906 (34 Stat. 225, 16 U.S.C. 432-433) or the Archeological Resources Protection Act of 1979 (93 Stat. 721; 16 U.S.C. 470aa-11) and State laws where applicable.
  - If, during excavation work, items of substantial archeological or paleontological value are discovered, or a known deposit of such items is disturbed, the Grantee will cease excavation in the area so affected. Grantee will then notify the Forest: Service and will not resume excavation until written approval is given.

. The Chief, Forest Service, may terminate this easement, or any segment thereof, (1) by consent of the Grantee, (2) by condemnation, or (3) after a five (5) year period of nonuse, by a determination to cancel after not fication and opportunity for hearing as prescribed by law.



THIS EASEMENT, dated this 2nd day of October, 1987, from the UNITED STATES OF AMERICA, acting by and through the Forest Service, Department of Agriculture, hereinafter called Grantor, to the Girz County Board of Supervisors, hereinafter called Grantee.

#### WITNESSETH:

This grant is made subject to the following terms, provisions, and conditions:

- 1. Outstanding valid claims, if any, existing on the date of this grant.
  - 2. The easement herein granted is limited to use of the described right-of-way for the purpose of construction, operation, and maintenance of a highway and does not include the grant of any rights for nonhighway purposes or facilities; Provided, That the Forest Service shall not exercise its right to use or authorize the use of any portion of the right-of-way for nonhighway purposes when such use would interfere with the free flow of traffic or impair the full use and safety of the highway; and Provided further, That nothing herein shall preclude the Forest Service from locating National Forest and other Department of Agriculture information signs on the portions of the right-of-way outside of construction limits.

  - (a) Protect and preserve soil and Vegetative cover and scenic and esthetic values on the right-of-way outside of construction limits.
  - (b) Provide for the prevention and control of soil erosion within the right-of-way and adjacent lands that might be affected by the construction, operation, or maintenance of the highway, and shall vegetate and keep vegetated with suitable species all earth cut or fill slopes feasible for revegetation or other areas on which ground cover is destroyed. The Grantee shall perform these activities where it is deemed necessary during a joint review between the authorized Forest Officer and Grantee prior to completion of the highway. The Grantee also shall maintain all terracing, water bars, leadoff ditches, or other preventive necessary to be works that may this objective. ## PUBLIC ROAD EASEMENT

THIS EASEMENT, dated this and day of October, 1987, from the UNITED STATES OF AMERICA, acting by and through the Forest Service. Department of Agriculture, hereinafter called Grantor, to the Gila County Board of Supervisors, hereinafter called Grantee.

WITHESSETH:

WHEREAS, the Grantee has applied for a grant of an easement under the Act of October 13, 1964 (78 Stat. 1089, 16 U.S.C. 532-538), for a road over certain lands or assignable easements owned by the United States in the County of Gila, State of Arizona, and administered by the Forest Service, Department of Agriculture.

NOW THEREFORE, Grantor does hereby grant to Grantee an easement for a public road and highway along and across a strip of land 50 feet on each side of the centerline hereinafter defined as the right-of-way over and across lands in the County of Gila, State of Arizona, as described in the plats entitled, "Plat of the Right of Way Survey Road No. 291, Tonto National Forest, I 10% and 11 N., R. 13 and 14 E., Gila and Salt River Meridian, Gila County, Arizona," hereby made a part hereof. The plat has been recorded in the Gila County records found at "Road 291, Record of Survey #244, 244A, 244B, 244C, 244D, 244E, and 244F."

The word "right-of-way" when used herein means said strip of land whether or not there is an existing road or highway located thereon. Except where it is defined more specifically, the word "highway" shall mean roads or highways now existing or hereafter constructed on the right-of-way or any segment of such roads or highways.

This grant is made subject to the following terms, provisions, and conditions:

- Outstanding valid claims, if any, existing on the date of this grant.
- 2. The easement herein granted is limited to use of the described right-of-way for the purpose of construction, operation, and maintenance of a highway and does not include the grant of any rights for nonhighway purposes or facilities; Provided, That the Forest Service shall not exercise its right to use or authorize the use of any portion of the right-of-way for nonhighway purposes when such use would interfere with the free flow of traffic or impair the full use and safety of the highway; and Provided further, That nothing herein shall preclude the Forest Service from locating National Forest and other Department of Agriculture information signs on the portions of the right\*of-way outside of construction limits.

- 3. Any reconstruction of the highway situated on this rightof-way shall conform with plans, specifications, and written stipulations, approved by the Forest Supervisor or authorized representative prior to beginning such reconstruction.
- 4. Consistent with highway sarety standards, the Grantee shall:
  - (a) Protect and preserve soil and vegetative cover and scenic and esthetic values on the right-of-way outside of construction limits.
  - Provide for the prevention and control of soil erosion within the right-of-way and adjacent lands that might be affected by the construction, operation, or maintenance of the highway, and shall vegetate and keep vegetated with suitable species all earth cut or fill slopes feasible for revegetation or other areas on which ground cover is destroyed. The Grantee shall perform these activities where it is deemed pecessary during a joint review between the authorized Forest Officer and Grantee prior to completion of the highway. The Grantee also shall maintain all terracing, water bars, leadoff ditches, or other preventive may be necessary to works that this objective. This provision also shall apply to waste disposal areas and slopes that are reshaped slides that occur during following construction.

#### 5. The Grantee shall:

Establish no borrow, sand, or gravel pits; stone quarry; permanent storage areas; sites for highway-operation and maintenance facilities; camps; supply depots; or disposal areas within the right-of-way, unless shown on approved construction plans, without first obtaining approval of the authorized Forest Officer.

6. The Grantee shall maintain the right-of-way clearing by means of chemicals only after the Forest Supervisor has given specific written approval. Application for such approval must be in writing and must specify the time, method, chemicals, and the exact portion of the right-of-way to be chemically treated.

- 7. The Grantee does by the acceptance of this document covenant and agree for itself, its assigns, and its successors in interest to the property here granted, or any part thereof, that the covenant set forth below shall attach to and run with the land:
  - That the Grantee shall operate the described property and its appurtenant areas and its buildings and facilities whether or not on the land therein granted as a public road; in full compliance with Title VI of the Civil Rights Act of 1964 and all requirements imposed by or pursuant to the regulations issued thereunder by the Department of Agriculture and in effect on the date of this document to the end that no person in the United States shall, on the grounds of race, sex, color, religion, or national origin, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any theredn: and provided programs or activities
  - (b) That the United States shall have the right to judicial enforcement of these covenants not only as to the Grantee, its successors and assigns, but also as to lessees and licensees doing business or extending services under contractual or other arrangements on the land therein conveyed.
- 8. The Regional Forester shall make determination as to the necessity for archeological and paleontological reconnaissance and salvage within the right-of-way, and such reconnaissance and salvage to the extent determined necessary because of maintenance of the highway facility is to be undertaken by the Grantee in compliance with the act entitled, "An Act for the Preservation of American Antiquities," approved June 8, 1906 (34 Stat. 225, 16 U.S.C. 432-433) or the Archeological Resources Protection Act of 1979 (93 Stat. 721; 16 U.S.C. 470aa-11) and State laws where applicable.
  - If, during excavation work, items of substantial archeological or paleontological value are discovered, or a known deposit of such items is disturbed, the Grantee will cease excavation in the area so affected. Grantee will then notify the Forest Service and will not resume excavation until written approval is given.

The Chief, Forest Service, may terminate this easement, or any segment thereof, (1) by consent of the Grantee, (2) by condemnation, or (3) after a five (5) year period of nonuse, by a determination to cancel after notification and opportunity for hearing as prescribed by law.

IN WITNESS WHEREOF, the Grantor, by its (Deputy) Regional Forester, Forest Service, has executed this easement pursuant to the delegation of authority to the Chief, Forest Service, 7 CFR 2.60, and the delegation of authority by the Chief, Forest Service, dated August 22, 1984 (49 FR 34283), on the day and year first above written.
